## Charging While Traveling

It can feel intimidating to try to plan a road trip with your electric vehicle (EV) not knowing where public charging stations are located.

Did you know Energy.gov has an "Alternative Fueling Station Locator" to help you map out your travel route based on available EV chargers? You can filter by type of charger, Level 1, Level 2, or DC Fast Charger, as well as by Connector type. This locator is available online as well as via an app for both Apple and Android devices. Be sure to check the locator often to ensure chargers are in working condition.
