## Wastewater Treatment Facility Stack Filter Upgrade

The Wastewater Treatment Facility (WWTF) has commenced on a significant upgrade project. A WWTF Master Plan study was conducted in 2022. The Study identified a critical need for the nearly 50-year-old Stack Filters and Final Clarifiers to be upgraded. Equipment associated with both of these processes is crucial to producing permit-compliant effluent. The stack filters provide most of the wastewater treatment and the final clarifiers remove suspended solids before the treated water is discharged to Lake Michigan.

In Wisconsin, nearly all significant capital improvement projects at municipal wastewater treatment facilities are funded with the Clean Water Fund Program (CWFP), which provides public treatment facility owners financial assistance in the form of subsidized loans, additional subsidies that reduce the size of the loan (principal forgiveness), or a combination. Principal forgiveness is similar to a grant. MPU received \$2.1M in principal forgiveness funds from the CWFP to help pay for this significant upgrade, with the remaining costs being paid over 20-years via a Wisconsin Department of Natural Resources low interest loan.

Construction began at the beginning of February and is expected to be completed by the end of 2026.

## UniDirectional Flushing -Main Zone

UniDirectional flushing (UDF) is a method used to clean and improve the carrying capacity of our water distribution system. This cleaning method helps us continue to provide safe, high-quality drinking water to our customers. Every summer, MPU performs UDF in strategic areas of the city. If your address is located within one of these areas, you will receive a notification mailer. Additionally, water department staff place sandwich board signs near the area so neighborhoods are aware. This summer, MPU will be performing UDF in the Main Zone, which is the largest. This work is anticipated to begin in April and will last a few months.

During flushing, hydrants are flushed onto the road, which can cause a brief buildup of water. Customers in the immediate vicinity of where flushing is taking place may experience a temporary drop of pressure. If this occurs, please be assured that utility staff work diligently to minimize any inconveniences. **What should you do in your home if flushing is** occurring nearby?

If possible, avoid using water while we're flushing in your neighborhood.



You may experience some discolored water. If that occurs, run your cold water until it is clear.



### **Tree Trimming**

MPU is required by Wisconsin State Electrical code to maintain clearance between trees and power lines. Trees contacting power lines can cause power outages, fire hazards, and other dangerous conditions. To avoid those issues, MPU, or our contracted third-party, trims trees that are impeding on electric power lines. Primarily this work is completed in the winter or springtime. If we anticipate trimming on your property, you will receive a letter notifying you. Tree trimming work will largely be completed this spring in the Northeast quadrant of the City of Manitowoc.

#### Storm season is coming! Here are some tips:

- Pack an emergency kit! Kit suggestions can be found at ready.gov.
- Save our electric emergency line number to report outages or downed power lines: 920-683-4622. If you see a downed line, stay away from it! It could be energized and dangerous.
- If you see a crew working in the street to restore power, especially at night, please drive slow, obey any cones or traffic changes, and give the crew plenty of space.

#### Winter Disconnection Moratorium Ending

The winter moratorium on residential electric disconnections for non-payment ends on April 15th. MPU urges customers to make payment arrangements, and, if eligible, apply for energy assistance. *Energy assistance is there to help you*. The table to the left lists the guidelines for eligibility. Your previous month's income must be equal to, or less than, these numbers, which are determined by the federal government. Assistance applications are processed by Partners for Community Development. Once the application has been fully processed and approved, the benefit will appear as a credit on a future MPU bill.
